

ABM Industries Continues Best-Ever Quarterly Dividend Rate

SAN FRANCISCO – March 5, 2007 – The Board of Directors of ABM Industries Incorporated (NYSE: ABM) has declared an all-time-high second quarter cash dividend of \$0.12 per common share payable on May 7, 2007 to stockholders of record on April 12, 2007. This will be ABM's 164th consecutive quarterly cash dividend, and is \$0.01 (9.1%) above the \$0.11 per share quarterly dividend rate declared and paid for the second quarter of 2006.
