Units vest 50% on the second anniversary of the grant date and 50% on the fourth anniversary of the grant date, and will settle in shares of common stock. Dividend equivalent rights (DERs) will accrue.
- Includes 14,437 unvested RSUs, 1,396 vested RSUs, the receipt of which has been deferred and DERS relating to the RSUs, adjusted to reflect the cumulative effect of fractional shares, 1,441 performance shares earned but not vested with respect to performance shares granted on 1/14/2014, 392 performance shares earned but not vested with respect to performance shares granted on 1/15/2015, and DERs related thereto.
