Explanation of Responses:

- Restricted stock units (RSUs) granted under the 2006 Equity Incentive Plan, representing a contingent right to receive shares of common stock. Units vest 50% on the second anniversary of the grant date and 50% on the fourth anniversary of the grant date, and will settle in shares of common stock. Dividend equivalent rights (DERs) will accrue.
- Includes 54,806 RSUs and DERs relating to the RSUs, adjusted to reflect the cumulative effect of fractional shares, and 9,366 performance shares earned but not vested with respect to performance shares granted on 1/12/2009 and DERs related thereto.
- Stock option grant under the 2006 Equity Incentive Plan.
- 25% exercisable on 9/8/2011, and 25% on the anniversary date of each of the following 3 years.
